



## Cucumber exports from the Terminal de Contenedores de Yucatán reach an all time high

• Between November 2012 and April 2013, TCY moved around 30,000 tonnes of the vegetable to the North American market

**Barcelona, 6 June 2013.**- Cucumber exports from the Mexican state of Yucatán reached a historical high last season. Between November 2012 and April 2013, the **Terminal de Contenedores de Yucatán (TCY)**, belonging to **Grup Marítim TCB**, moved around 1,500 40 foot refrigerated containers, the equivalent of 30,000 tonnes of the vegetable. The American company in charge of distributing and marketing the product along the U.S. east coast is **Southern Valley**, active in Yucatán since 2003 and carrying out 100% of its exports from TCY in Puerto Progreso.

Rich in calcium, chlorine, potassium and iron, cucumber is grown in the south of the state of Yucatán. The previous export record for this product dates back to the 2008/2009 season, when 1,271 containers were transported.

Puerto Progreso has gradually become an international reference for the export of these farm products, as well as others such as citrus fruits and watermelons, and is an important driver for the local economy. Located in the Yucatán Peninsula, southeast of the Gulf of Mexico, it connects import and export companies to large commercial markets in Europe and the Americas.

Grup Marítim TCB has managed the Terminal de Contenedores de Yucatán since 2005 to provide shipping companies with quality services in the movement of goods. Its policy of technical and technological innovation is reflected in its current equipment, comprising two Panamax gantry cranes, one mobile crane and five reach stackers. TCY has a surface area of 11.5 hectares, a total of 480 metres of docks up to 11.3 metres deep.
