



## **Logwin expands and upgrades its Vietnam logistics facilities**

Logwin, a global leader in air and ocean freight and logistics services, has moved its warehousing and logistics operations into a modern, state-of-the-art purpose built facility close to Hanoi. The warehousing complex will serve the north of the country.

The facility comprises 5,200 sqm of bonded warehousing, long term storage and an area for specialist logistics services mainly for fashion industry customers. This will include pick-and-pack, commissioning, price labeling and consolidation services.

Logwin's Hanoi warehouse is located less than 30 minutes by road from Vietnam's capital city and is close to the international airport at Noi Bai and Haiphong international seaport.

"The new logistics and warehousing facility is driven by growth in demand from our customers in Vietnam as the economy continues to grow and the export manufacturing sector develops. Manufacturers now actively look at leveraging the lower land and labour costs in Vietnam," said Maik Juengst, Country Director Vietnam at Logwin.

Logwin has strategically located facilities in the North, Central and South of Vietnam close to the major manufacturing centres where its customers are based.

The company has a 2,000 sqm Container-Freight Station (CFS) operations in Haiphong. In Ho Chi Minh City, Logwin operates a warehouse CFS facility that has a state-of-the-art racking system and storage capacity of 1,000 pallet positions.
